CHECK-IN

Gate sheets will be posted ringside. Any changes in running order must be done by the Gate Steward for each class.

CRATING AND SETUP

The trial hours are as follows: Friday – 7:00 a.m. – 6:00 p.m.; Saturday – 7:00 a.m. – 8:00 p.m.; Sunday – 7:00 a.m. – 7:00 p.m. The building will NOT be open for crating on Thursday evening. There will be plenty of space available for indoor crating. **Please bring a waterproof tarp to place underneath your dog's crate.** Crates may be left overnight; however, neither SSCGB nor CISC will be responsible for any lost or damaged items left at the show site. Dogs may not be left overnight.

Crate aggressive dogs must be covered and may not be positioned on aisle corners or at doorways. If complaints are received, handlers will be asked to move their dogs.

COVID INFORMATION

The SSCGB will follow the recommendation of the CDC at the time of the event and any Carroll County guidelines in effect at the time of the event.

PARKING

There is plenty of parking available on-site.

COURSE MAPS

Course maps will be made available on SSCGB's Website by 6:00 a.m. the morning of each trial (<https://www.shetlandsheepdogclubofgreaterbaltimore.org/>). Course maps will also be posted at the trial site for exhibitors to photograph.

FOOD

Food will be available on site.

MEASURING

Dogs that do not have a valid Jump Height Card (permanent P-card or a temporary yellow measurement sheet) must be measured prior to their first run. Since our judge is not a Volunteer Measuring Official (VMO), all measurements will only be effective for the weekend of our trials.

VOLUNTEERS NEEDED

Thank you in advance for volunteering! A sign-up board will be on-site each day. A successful trial is dependent upon its volunteers! Coupons will be given to each worker to offset costs of future entries or to use at the food vendor. Each day, a worker raffle will be held for free future entries and other prizes.

DOG POTTY AREA

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations on the show grounds. Please do not allow dogs to potty in front of the building.

MOVE-UP INFORMATION

The deadline for move-ups is Monday, April 22 at 6:00 p.m. Please email move-up requests to the Trial Secretary (Debbie Kaminski – dekamin@aol.com). Day-to-day move-ups will be allowed between the trials and will be collected up to one-half hour after the conclusion of the last class on both Friday and Saturday. Move-ups must be submitted in writing at the trial site to the Trial Secretary. Move-up forms will be available on-site.

DIRECTIONS TO TRIAL SITE

Carroll Indoor Sports Center (CISC)

515 Old Westminster Pike, Westminster, MD 21157

From Baltimore: From Baltimore Beltway (I-695) take Exit 19, Northwest Expressway (I-795) towards Owings Mills/Reisterstown. Continue until the Expressway ends, bear right onto Route 140 West. Follow 140 West for approx. 10 miles, turn left onto Route 97 (Weis Market on right, PetSmart on the left.) At the 2nd light, turn Left onto Old Westminster Pike. The Carroll Indoor Sports Center will be on the right a short distance after the turn.

From DC & Virginia: From I-495 take I-270 exit towards Frederick. From I-270, take Damascus exit (Route 27 North). Stay on Route 27 North approx. 25 miles to Main Street in Westminster. Turn right onto Main Street. Travel 1.5 miles. Carroll Indoor Sports Center will be on right side of road after crossing over Route 97.

Go 1.1 miles and, at the MVA sign, make a U-Turn onto Baltimore Blvd (MD-140). Go .1 mile and turn right and then turn left into the plaza.
